In consideration of being permitted to participate in the river trip, the undersigned hereby **RELEASES AND DISCHARGES** the ZOAR VALLEY CANOE & RAFTING COMPANY, INC., its owners, stockholders, officers, directors, employees, agents and landowners who have consented to the use of their property, and their heirs, successors, executors and assigns all claims, demands, rights of causes of action, present or future, whether known, anticipated or unanticipated and resulting from, or arising out of, or incident to, the river trip, the equipment and facilities, the negligent acts of said Company, its stockholders, directors, officers, employees and agents and any first aid, treatment or service rendered to the undersigned during participation in such river trip.

The undersigned agrees to indemnify and hold forever harmless said ZOAR VALLEY CANOE AND RAFTING COMPANY, INC., against any and all claims, demands or action which may hereafter at any time be made or instituted against said Company by the undersigned, his/her executors, heirs or assigns. I hereby grant permission to ZVC to make photographic records of this trip without recourse or compensation to me. If any part of this release is held invalid it is agreed that the balance shall continue in full force and affect.
